### **EXPERT PANEL:**

DR. MARUJA ASIS is Director of Research and Publications at the Scalabrini Migration Center, Manilla, Philippines. She is a sociologist who has long been working on international migration and social change in Asia. Her areas of interest and research experience include gender, family and migration;



research experience include gender, family and migration; migration and development; and migration governance. She

recently completed work on youth, employment and migration in the Philippines; assessment of pre-departure information programs for migrants in Indonesia, the Philippines and Nepal; and the displacement of Filipino workers in Libya and Syria. She is co-editor of the Asian and Pacific Migration Journal. She has authored various publications and has participated in many international conferences.

AMBASSADOR LUIS CRUZ is the Assistant Secretary for ASEAN Affairs at the Department of Foreign Affairs. He has served the country in the People's Republic of China (Beijing and Guangzhou), Malaysia and the Republic of Korea and has assumed various capacities, including Director General for ASEAN Affairs, Principal Assistant to the Undersecretary for



Policy and Director for China Division. He was also the Assistant Secretary for ASEAN Affairs from 2006 until 2008, during which he chaired meetings of ASEAN functional committees. He has organized the ASEAN Open Lecture Series in various Philippine schools and universities to promote awareness about ASEAN and its impact on the young generation of Filipino students. He is recipient the Lakandula Achievement Award from the Office of the President and the Gawad Mabini Leadership Award from the Department of Foreign Affairs for his outstanding work during the one-year Philippine chairmanship of ASEAN.

DR. STEFAN ROTHER is a Researcher and Lecturer at the Department of Political Science, University of Freiburg, Germany. His specializes in international migration, global governance, social movements, regional integration and non-/post-Western theories of international relations. His current research project is "Democratisation from below? Newly



emerging transnational political spaces for migrants' rights activists in Southeast Asia". Dr. Rother was editorial manager of the International Quarterly for Asian Studies and Senior Researcher at the Arnold-Bergstraesser-Institute for Sociocultural Research at the University of Freiburg. #### RESEARCHING ASEAN:

### Harmonizing Migration Policy

Migration movements define the quality of human life. Individuals and communities have since time unremembered roamed the earth in search of food and shelter for its own survival. This phenomenon is ubiquitous and necessary in the project of ASEAN integration alongside capital and commercial goods. ASEAN is home to 600 million people, has the third-largest labor force in the world and is projected to rank as the fourth largest economy by 2050. Mobilizing human capital is a veritable challenge:

- How will this be done in the context of diverse and divergent socio-cultural traditions and national demographic trends?
- Does it open up opportunities for progressive change?
- What will be the most decisive roles and who will play them?

# Office of United Nations and International Organizations of the Department of Foreign Affairs (DFA-UNIO)
